Essential Protective Equipment and Supplies:

- Face Covering for two years old and over, adults must use an N95 mask
- Staff wears gloves: during Food, Trash, Cleaning/Disinfecting, and Diapering. A NEW pair for each task.
- Hand Sanitizer at least 60% ethyl alcohol, 70% isopropyl alcohol Children are supervised if using a Hand Sanitizer, hand washing is more effective.
- HEPA Air Purifier

Planning:

- Temperature is taken every morning before entering school (over 99 stay home.
- Guidelines are updated and added to THE COVID-19 BINDER
- The isolation Room is ready on-premises

Cleaning:

- Fresh outdoor air as with opening the windows
- When cleaning and airing out the house before the kids arrive
- Deep clean when kids are not at school
- High-touch surfaces are disinfected after each child (bathroom, doorknobs, tables)
- Toys are removed at the end of each day and replaced with clean, sanitized toys
- We are a Certified Green Business; we use appropriate cleaning solutions for the environment
- All soft surface household linings are washed at the end of each day
- All kids have clean, sanitized clothing in their own labeled bags
- All kids have clean, sanitized bed linings that are washed every day

Hygiene:

- Handwashing for 20 sec is done when kids arrive, during each transition, after outside play, before/after eating, and before going home.
- Bathroom time is done at every transition change. Healthy handwashing is reinforced, and the bathroom is sanitized.
- We reinforce "no tough" eyes, nose, mouth, and sneeze and cough in your elbow, please. Hand washing for 20 sec
- Personal items and bedding (under Cleaning)

Arrival Procedures:

- Parents Stay outside at drop-off and pick-up with masks on
- Drop-off: is done on a staggered basis.
- Pick-up: on a staggered basis, 5 min text before pick-up, so we can get your child ready.
- Colored boxes are outside so the kids can put all of their belongings in the box for a safe distancing pick up and drop off.
- Hand sanitizer is outside at the front door
- Same parent picks-up and drops-off

Health Screening:

All staff and Families are asked:

• Has...

-you or anyone in your household had any symptoms of illness in the last two weeks (including fever, chills, cough, shortness of breath, difficulty breathing, the new loss of taste/smell, headaches, fatigue, general body aches, sore throat, congestion / runny nose, nausea/vomiting, diarrhea)

-you have been exposed to anyone who has tested positive for COVID-19 or who has shown symptoms in the past two weeks

-you have been advised to self-quarantine because of exposure to someone with a coronavirus infection.

- If someone in your family/ co-worker/ classmate/ staff is required to quarantine, please have all family stay home until everyone in the family has tested negative with a PCR test, at least 72 hours after exposure.
- Temperature is taken every morning.
- Covid negative test every Monday before school and if you have returned from a vacation of any kind.

- Staff and Children are monitored every day for signs of illness
- If any Staff, Child, or Parent shows any symptoms, they are to self-quarantine for 14 days and notify their physicians.
- Return with physician's letter of clearance and CDC criteria
- Self-isolation

Group Size and Staffing:

- Children should remain in groups as small as possible
- Keep the same children and staff together in one group
- Keep siblings together in the same group

Classroom Space and Distancing:

- Arrange activities, furniture, and play area to maintain as much distance as posable
- Napping places kids with heads in the opposite direction
- Use opportunities to spend more time outdoors
- More individual olay
- Clean all outdoor play areas
- Have half of the kids outside play and half the kids inside playtime

Meal Time:

- Kids are spread out to ensure proper spacing
- Proper handwashing is implemented
- Family-cafeteria-style meals are no longer allowed
- All flatware is washed and sanitized in the dishwasher after every use
